Relationship and Sex Education (RSE) Policy

Our vision:

We believe in the potential of every child regardless of background or individual needs as expressed in Luke 15, The Parable of the Lost Sheep. We are committed to providing an emotionally supportive environment, where pupils flourish, growing both spiritually and academically; securing foundations for each child to understand who they are and the unique qualities they bring to the world

As a maintained primary school we must provide relationships education to all pupils as per section 34 of the Children and Social work act 2017.

Rationale

"All schools must have in place a written policy for Relationships Education and RSE. Schools must consult parents in developing and reviewing their policy. Schools should ensure that the policy meets the needs of pupils and parents and reflects the community they serve. The policy must:

- Define relationship and sex education;
- Describe how relationship and sex education is provided and who is responsible for providing it;
- Say how relationship and sex education is monitored and evaluated;
- Include information about parents' right to withdrawal from sex education that is not part of the science national curriculum.; and
- Be reviewed regularly"

Moral and Values Framework

Relationship and sex education (RSE) is lifelong learning about physical, sexual, moral and emotional development. It is about the understanding of the importance of stable and loving relationships, respect, love and care, for family life. It involves acquiring information, developing skills and forming positive beliefs, behaviours, values and attitudes.

Relationships education focuses on teaching the fundamental building blocks and characteristics of positive relationships including:

- Families and people who care for me
- Caring friendships
- Respectful relationships
- Online relationships
- Being safe



The teaching programme for Relationship and Sex Education

Legal requirements

All schools must teach the following:

National Curriculum Science

Key Stage 1

- identify, name, draw and label the basic parts of the human body and say which part of the body is associated with each sense.
- notice that animals, including humans, have offspring which grow into adults.
- describe the importance for humans of exercise, eating the right amounts of different types of food, and hygiene.

Key Stage 2

- describe the life process of reproduction in some plants and animals.
- describe the changes as humans develop to old age.

Relationships Education.

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults

Families and people who care for me

Pupils should know:

- that families are important for children growing up because they can give love, security and stability
- the characteristics of healthy family life, commitment to each other, including in times of difficulty, protection and care for children and other family members, the importance of spending time together and sharing each other's lives
- that others' families, either in school or in the wider world, sometimes look different from their family, but that they should respect those differences and know that other children's families are also characterised by love and care
- that stable, caring relationships, which may be of different types, are at the heart of happy families, and are important for children's security as they grow up
- that marriage represents a formal and legally recognised commitment of two people to each other which is intended to be lifelong
- how to recognise if family relationships are making them feel unhappy or unsafe, and how to seek help or advice from others if needed



Caring friendships

Pupils should know:

- how important friendships are in making us feel happy and secure, and how people choose and make friends
- the characteristics of friendships, including mutual respect, truthfulness, trustworthiness, loyalty, kindness, generosity, trust, sharing interests and experiences and support with problems and difficulties
- that healthy friendships are positive and welcoming towards others, and do not make others feel lonely or excluded
- that most friendships have ups and downs, and that these can often be worked through so that the friendship is repaired or even strengthened, and that resorting to violence is never right
- how to recognise who to trust and who not to trust, how to judge when a friendship is making them feel unhappy or uncomfortable, managing conflict, how to manage these situations and how to seek help or advice from others, if needed

Respectful relationships

Pupils should know:

- the importance of respecting others, even when they are very different from them (for example, physically, in character, personality or backgrounds), or make different choices or have different preferences or beliefs
- practical steps they can take in a range of different contexts to improve or support respectful relationships
- the conventions of courtesy and manners
- the importance of self-respect and how this links to their own happiness
- that in school and in wider society they can expect to be treated with respect by others, and that in turn they should show due respect to others, including those in positions of authority
- about different types of bullying (including cyberbullying), the impact of bullying, responsibilities of bystanders (primarily reporting bullying to an adult) and how to get help
- what a stereotype is, and how stereotypes can be unfair, negative or destructive
- the importance of permission-seeking and giving in relationships with friends, peers and adults

Online relationships

Pupils should know:

- that people sometimes behave differently online, including by pretending to be someone they are not
- that the same principles apply to online relationships as to face-to-face relationships, including the importance of respect for others online including when we are anonymous

- the rules and principles for keeping safe online, how to recognise risks, harmful content and contact, and how to report them
- how to critically consider their online friendships and sources of information including awareness of the risks associated with people they have never met
- how information and data is shared and used online

Being safe

Pupils should know:

- what sorts of boundaries are appropriate in friendships with peers and others (including in a digital context)
- about the concept of privacy and the implications of it for both children and adults; including that it is not always right to keep secrets if they relate to being safe
- that each person's body belongs to them, and the differences between appropriate and inappropriate or unsafe physical, and other, contact
- how to respond safely and appropriately to adults they may encounter (in all contexts, including online) whom they do not know
- how to recognise and report feelings of being unsafe or feeling bad about any adult
- how to ask for advice or help for themselves or others, and to keep trying until they are heard,
- how to report concerns or abuse, and the vocabulary and confidence needed to do so
- where to get advice, for example family, school or other sources

Sex education

<u>Year 5</u>:

- To provide reassurance that body changes, physical, emotional and social are normal and acceptable.
- To counter myths and misinformation and to examine opinions and encourage discussion.
- To inform the children of the changes that male and female bodies undergo during puberty.
- To recognise the emotional changes that occur during puberty and how these can affect their relationship with others.

<u>Year 6:</u>

- To understand how puberty is the preparation for adulthood (including making decisions about sexual relationships).
- To build on their knowledge of life cycles and learn about the basic biology of human reproduction including how babies are made.

Relationship and sex education should focus on the development of skills and attitudes not just the acquisition of knowledge.

Throughout both key stages any questions raised by the children will be answered by staff, with parental support, honestly and age appropriately.



Teaching and Learning

Mrs Cook is the designated teacher with responsibility for co-ordinating relationship and sex education.

As part of a whole school health education programme, relationship and sex education is addressed through many areas with particular emphasis on science and PSHE.

Relationship and sex education is taught by classroom teachers and if appropriate, outside visitors such as the school nurse.

A range of teaching methods which involve children's full participation are used to teach relationship and sex education. These include use of DVD, discussion and problem solving activities.

Sex education is usually delivered in single gender groups however they will get the opportunity to gain an understanding and awareness of issues related to both genders.

Pupils will be at different levels of maturity and have differing attitudes and feelings. Lessons should allow for this and enable all contributions to be valued and respected. The needs of pupils with SEND should be taken into account by the teacher who may need to provide different resources, activities or specific support to some pupils.

Equal Opportunities

The school's equal opportunities policy applies to RSE. Where appropriate, teaching materials and individual group activities reflect the cultural and ethnic diversity of British society. Pupils' religious beliefs will be respected. We undertake to follow the principles in the Church of England Charter for faith sensitive and inclusive relationships education, relationships and sex education (RSE) and health education (RSHE). Parents' wishes and guidance will be taken into account throughout the implementation of the RSE programme of work. The needs of pupils with SEND should be taken into account by the teacher who may need to provide different resources, activities or specific support to some pupils.

Monitoring and Evaluation

Monitoring is the responsibility of the Head teacher, linked Governor and teacher with responsibility for RSE. The school will assess the effectiveness of the aims, content and methods in promoting students' learning through questionnaires/discussion with teachers and children and feedback from parents.

The effectiveness of the RSE programme will be evaluated by assessing children's learning and implementing change if required.



Right of Withdrawal of Students from Relationship and Sex Education

Parents do not have the right to withdraw their children from relationships education. Parents do have the right to withdraw their child(ren) from all or part of the Sex Education programme that is not included in the Programme of Study for the Science National Curriculum.

Any parent wishing to withdraw a child from the programme should inform the Headteacher in writing of their decision.
